3. **PREVIOUS MODELLING EXPERIENCE - RAMP & PAGEANT MODELLING IS ESSENTIAL!**
4. If the contestant is are under the age of 18 they must obtain permission from their parent/guardian before entering this competition.
5. You must provide your name, email and contact details if you wish to enter this competition. Beyond 2000 Performing Arts will only use your personal details for the purpose of this competition, and will not publish them or provide them to anyone without your permission.
6. Two (2) photo's must accompany your entry form. **PAPER PRINTED PHOTO'S & CELL PHONE SELFIES WILL NOT BE ACCEPTED**
